



## EVENT LOCATION REQUIREMENTS

THE CLIENT MUST INITIAL EACH OBLIGATION LINE, IF ANY OF THESE EVENT OBLIGATIONS ARE NOT SATISFIED THE ARTIST WILL NOT PERFORM AND FULL AMOUNT CONTRACTED SHALL IMMEDIATELY BECOME DUE TO THE ARTISTS. ANY OBLIGATIONS CLIENT CANNOT SATISFY MUST BE APPROVED BY THE ARTIST PRIOR TO EVENT IN WRITING. NO OTHER PARTY(S) CAN OVERRIDE THESE OBLIGATIONS.

- \_\_\_\_ Artist must have access to performance space including stage no less than 4 hours prior to performance. Load in/out must be accessible by elevator or ramp, NO STAIRS.
- \_\_\_\_ Stage MUST be at least 12 inches off ground, NO smaller than 24' wide and 12' deep. If possible, set up event room the long way for better sound quality.
- \_\_\_\_ 3/20 Amp power supply MINIMUM
- \_\_\_\_ If performance is outdoors tent cover required for stage and sound technician. Ample heaters for stage and sound technician if under 55 degrees. In the event of inclement weather, the equipment cannot be moved once it is set up and job will be considered terminated at that time. If client determines because of either inclement weather or their failure to obtain alternate facilities not present at original location, Artist shall nevertheless be paid in full the contracted price.
- \_\_\_\_ Green room (dressing room) must be large enough for 10 people with seating and tables. Room should be for Artist use ONLY and be a secure place for personal belongings. Room must be available from 4 hours prior to performance through breakdown.
- \_\_\_\_ Client agrees to assume responsibility for all damages to Artist equipment by any party not directly associated with the Artist.
- \_\_\_\_ Meals for 10 people must be provided in green room one hour before performance.
- \_\_\_\_ Beverages should be at room temperature with drink ice provided.
  - Bottled Water 36+ Qty
  - Diet and Regular Cola and Lemon Lime Soda 36+ Qty
- \_\_\_\_ Meal Option Preferences: All meals should include assorted fruit, cookies, tossed salad, appropriate condiments and utensils.
  - Two Options: Notify Artist management 14 days prior performance.
    - \$150.00 cash buyout, which allows artist meal of their preference.
    - Hot Plated Meal: One meat (Fish, Poultry or Beef), one starch and one vegetable.
- \_\_\_\_ Final payment to be made in the form of cash or check (made out to: Red George Productions) no later than 30 minutes prior to performance.
